This Contract and Security Agreement covers all goods and services which the undersigned purchases from or enters into a contract with Greene's Inc. The undersigned expressly grant Greene's Inc. a security interest in all accounts receivable, inventory and equipment, both current and after-acquired, to secure amounts which are currently owed or may arise under this Contract and Security Agreement. The undersigned authorizes Greene's Inc. to execute and file all documents necessary to perfect and continue the security interest granted herein.

This Contract and Security Agreement constitutes the entire agreement between parties. No waivers or modifications hereof shall be valid unless made in writing and executed by the undersigned and Greene's Inc. This Contract and Security Agreement shall apply and inure to the benefit of, and be binding upon the heirs, executors, administrators, successors, and assignees of the respective parties.
